Tig headed out on his journey down the Net-Zero Pathway toward the land of the League of Stakeholders.








During his journey, he encountered a group of goblins who had trapped a centaur in a net. One of the goblins noticed Tig and threatened him, "Find another way or you'll be next."


Tig and Fred crossed the Fields of Green Finance and climbed the Mountain of Corporate Governance as they made their way to the lands of the Suppliers' Guild.
